

## Troop 777 Trek Sign Up

- Activity:** *Crystal Cove State Park Beginner Backpack*
- Date:** *August 19 to 20, 2017*
- Description:** Beginner Backpack trip from Crystal Cove State Park entrance to the Upper Moro Primitive Campground in Laguna Hills.  
Approximately 3 miles hiking each day through coastal sage scrub/chaparral and riparian terrain, leading to ocean view bluff. There will be many opportunities for signoffs. - Prerequisite(s):** A completed and signed Trek sign-up form and full payment. Scouts must be registered and complete a Troop 777 day hike. If this is your first Troop 777 backpack, you must complete a gear check at the Troop Meeting on August 14th with the backpacking instructor or trek SPL.
- Depart:** *Saturday, August 19th, 8:30am @ Dick's in Encinitas*
- Return:** *Sunday, August 20st, ~2:00pm @ Dick's in Encinitas*
- Cost:** *\$28 per person - also bring money for lunch on the drive home.*
- Other:** *Volunteers for cook masters and assistants are needed.*  
You will need backpacking gear, your 10 essentials, clothing for proper layering/weather protection, and hiking boots or sturdy shoes. Trekking poles will be handy for rolling terrain, but are not needed.  
**We will need to pack all water for this trek! No water source at campsite.**  
Plan to buddy up for tents. We will have a brief talk at the August 14th troop meeting to cover any details, and the food buy will be Thursday the week before the trek.
